The Okhahlamba Local Municipality is looking for a suitably qualified service provider to align the Business Continuity Plan (BCP) and the Disaster Recovery Plan (DRP). The organisation has the business continuity plan which was developed in 2021 and the Disaster Recovery Plan developed before Covid 19 Pandemic. The BCP was not aligned to the DRP.

The scope of the projects include:

- Review the organisation BCP to ensure the alignment with the DRP
- Recommend changes and update the ICT DRP where gaps have been identified that will
  result in conflict between DRP and BCP.
- Conduct simulation Test for both BCP and ICT DRP and update accordingly

- 1.3. THIS BID IS SUBJECT TO THE PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT AND THE PREFERENTIAL PROCUREMENT REGULATIONS, 2017, THE GENERAL CONDITIONS OF CONTRACT (GCC) AND, IF APPLICABLE, ANY OTHER SPECIAL CONDITIONS OF CONTRACT.
