- Understand the basic legal requirements of fuel tank at work
- The application of SABS 1398, SABS 1518 and SABS 0231 with respect to road tank vehicles, transportation, and loading, the driver and vehicle inspection schedules is explained.
- Specific precautionary measures are identified for the safety of workers and the public during the transportation process.
